The Board of County Commissioners of Clatsop County, Oregon ordains as 7 8 follows: 9 SECTION 1. The Board of County Commissioners of Clatsop County, Oregon, recognizes that 10 11 the Northeast Community Plan, as adopted by the Board of County Commissioners by 12 Ordinance 79-14, needs periodic revision and amendment. In the interest of the 13 health, safety and welfare of the citizens of Clatsop County and in accordance 14 with the recommendation of the Clatsop County Planning Commission, the Board of 15 Commissioners hereby determines the necessity of amending the Northeast Community 16 Plan to meet the County's needs for agricultural lands. The amendment as included herein shall be incorporated onto the Northeast 17 18 Community Comprehensive Plan Map and Zoning Map, and the Board of Commissioners 19 finds that the amendment complies with the Northeast Community Plan and the 20 following Statewide Planning Goals: 3 through 14. 21 The Board of County Commissioners further determines and takes notice that 22 the adoption procedure for this amendment complies with Statewide Plannings Goals **23** l and 2, the Citizen Involvement and Land Use Planning Goals respectively. Review and comment on the proposal was sought from the public members of 24 25 the Northeast Citizen Advisory Committee. The Clatsop County Planning Commission 26 conducted a public hearing pursuant to the requirements of ORS 215.060 on June 10, Page 1 Ordinance 80-8.

- 1 1980 for the purpose of public Planning Commission review of this request
- 2 submitted by Carol Newman to amend the Comprehensive Plan Map. The Board of
- 3 Commissioners recieved and considered the Planning Commission's recommendations
- 4 on this proposed amendment. The Board of Commissioners conducted a public hearing
- 5 pursuant to law on this ordinance on July 23, 1980 and adopted this ordinance on
- 6 July 23, 1980.

7 SECTION 2. EFFECTIVE DATE.

- 8 This ordinance shall be in full force and effect immediately upon the date
- 9 set forth in the emergency clause contained herein.

10 SECTION 3. EMERGENCY CLAUSE.

- 11 In order to implement the recommendations of the Planning Commission and
- 12 the findings of this Board with the greatest expedience and in order to realize
- 13 the benefits to be derived from the adoption of this element of the Comprehensive
- 14 Plan, this ordinance shall become effective immediately upon its passage and an
- 15 emergency is declared to exist.

16 SECTION 4. ADOPTION OF AN AMENDMENT TO THE NORTHEAST COMMUNITY PLAN.

- 17 The Board of Commissioners hereby adopts the Clatsop County Planning Commission
- 18 recommendation (Department of Planning and Development staff report of June 4, 1980
- 19 which by this reference is hereby incorporated herein) to change the designation of
- 20 the Northeast Community Plan for the portion of Tax lot 201, Section 36, Township
- 219 North, Range 7 West, Willamette Meridian lying North of Peterson Road from Rural
- 22 to Rural Exclusive Farm Use as an amendment to the Northeast Community Plan section
- 23 of the Clatsop County Comprehensive Plan.
